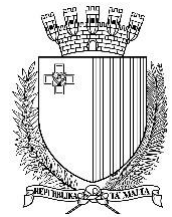

## Annex A

### Duties and responsibilities

- i. Reports directly to the Leading Assistance and Rescue Officer;
- ii. Undertakes to respond to a call in consequences of a fire or disaster/emergency or other similar occurrences necessitating immediate attention;
- iii. Tackles the immediate effects of a disaster, and provides assistance to rescue and help victims;
- iv. Handles related appliances, machinery and equipment;
- v. Assists Leading Assistance and Rescue Officer in carrying out inspections;
- vi. May be required to work at sea;
- vii. Assists the Director General as necessary;
- viii. Undertakes any other tasks, which the superior may delegate to him/her, as may be required;
- ix. Undertakes any other duties which may be updated to meet the requirements of any other area as confirmed by the Permanent Secretary.
- x. Any other duties as directed by the Principal Permanent Secretary.
