- iii. jkun responsabbli għall-kura tal-pazjenti taħt il-ħarsien tiegħu u għat-tmexxija u amministrazzjoni in ġenerali tat-tim tal-impjegati li jaqgħu taħtu skont id-direzzjoni taç-Chairperson Kliniku tal-Psikjatrija;
- iv. jkun responsabbli għas-superviżjoni klinika tal-pazjenti billi jattendi r-rondi tas-swali, kliniċi tal-outpatients, kliniċi taç-Ċentri tas-Saħħa, konsultazzjonijiet tas-swali u kwalunkwe assessjar ieħor, eżaminazzjonijiet jew attivitajiet terapewtiċi kif jista' ikun meħtieġ għall-kura xierqa tal-pazjent, u jkun ukoll meħtieġa li jipprovdi servizz ta' konsultazzjoni lill-kollegi kliniċi tiegħu;
- v. jagħmel użu mis-sistemi tat-Teknoloġija tal-Informatika li jkunu qed jintużaw fil-Ministeru għas-Saħħa.
- vi. jwettaq kompitu ieħor li s-superjur jista' jiddelega lilu, kif jista' jkun meħtieġ;
- vii. jwettaq dmir ieħor hekk kif ordnat mis-Segretarju Permanenti Ewlieni

Duties and responsibilities

- i. forms part of the Department of Psychiatry and being directly accountable to the Clinical Chairperson of Psychiatry and he/she will be expected in taking part in the activities of the Department of Psychiatry and participating in academic, teaching and in-service training programme as required;
- ii. be required to assume special responsibility for service delivery and further development of Peri-Natal Psychiatry Services as detailed by the Clinical Chairperson of Psychiatry, besides performing duties in Adult General Psychiatry. Which includes leading and co-ordinating the care of women with Peri-Natal mental ill health, as part of specialist multi-disciplinary Peri-Natal mental health provision in community settings and inpatients and may however be required to relinquish or alter the designated special responsibility according to the exigencies of the service;
- iii. be responsible for the treatment of patients under his/her care and for the overall management and administration of his/her own team of employees as per direction of the Clinical Chairperson of Psychiatry;
- iv. be responsible for the clinical supervision of his/her patients through attendance of ward rounds, out-patient clinics, health centre clinics, ward consultations and any other assessment, examination or therapeutic activities as may be required for proper patient care and will also be required to provide a consultation service to his/her clinical colleagues;
- v. makes use of the Information Technology systems which may be in operation within the Ministry for Health;
- vi. undertakes any other tasks, which the superior may delegate to him/her, as may be required;
- vii. carries out any other duties as directed by the Principal Permanent Secretary.
