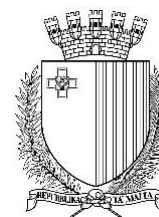

Duties and responsibilities

- i. In charge of the Fire Safety Section within the Civil Protection Department Force as stipulated by L.N. 234 of 2024 ;
- ii. In charge of the administration of the Fire Safety Section within the Civil Protection Department Force ;
- iii. Drafts the necessary policies related to this Section ;
- iv. Leads projects related to this Section ;
- v. Analyses and prepares feedback on policies and regulations emanating both from national entities and the EU ;
- vi. Promotes education and training on fire safety, evacuation, emergencies and first aid fire fighting ;
- vii. Establishes safe strategies and implement the necessary measures in public events ;
- viii. Indicates the necessary standards to promote a high level of public events safety ;
- ix. Monitors compliance with the relevant regulations and standards and take the necessary enforcement action in relation to public events ;
- x. Gathers data and statistics on fire safety and public events ;
- xi. Makes the necessary recommendations to the Director General of the Civil Protection Department ;
- xii. Undertakes any other tasks, which the superior may delegate to him/her, as may be required;
- xiii. Undertakes any other duties which may be updated to meet the requirements of any other area as confirmed by the Permanent Secretary.
- xiv. Any other duties as directed by the Principal Permanent Secretary.
