- xi. Jissorvelja il-proċess ta' revizjoni tat-testamenti ppubblikati min-nutara f'Malta u Ghawdex;
- xii. Jikkoordina is-Sezzjoni Nutarili biex jiġu mwiegħba fil-ħin il-mistoqsijiet ta' xejra legali u jiġi żgurat servizz ta' kwalità tajba lill-klijenti skont iċ-Charter dwar Servizz ta' Kwalità ezistenti;
- xiii. Jippromwovi l-Arkivji Nutarili kif jiġi delegat min-Nutar Prinċipali Ewlieni lill-Gvern;
- xiv. Jimmaniġġja kawżi fil-Qrati tal-Ġustizzja meta mqabba min-Nutar Prinċipali Ewlieni lill-Gvern;
- xv. Kwalunkwe komputu ieħor li n-Nutar Prinċipali Ewlieni tal-Gvern jista' jiddelega lilu/ha kif meħtieġ, inkluż fl-Uffiċċju tan-Nutar tal-Gvern f'Ghawdex.

Duties and responsibilities

- i. Leads the Notarial Section while overseeing the work of all Notaries and monitors their progress;
- ii. Prepares draft amendments to improve the laws relating to the Notarial Profession;
- iii. Prepares the Standard Operating Procedures relating to any legal matters within the Department;
- iv. Participates in legal fora, both locally and abroad relating to notarial practice;
- v. Assists the Chief Notary to Government when appointed Notary Keeper;
- vi. Organises the collection of notarial volumes from review officers, and coordinates with the National Archives with regards to their registers;
- vii. Works actively with the archivist or manager within the Archive to maintain the order of the notarial volumes;
- viii. Assists the Chief Notary to Government with any local or EU projects;
- ix. Trains junior notaries in the publication of deeds and private agreements;
- x. Drafts and publishes deeds, especially those of high importance, together with the Chief Notary to Government;
- xi. Oversees the review of wills published by notaries in Gozo and Malta;
- xii. Coordinates with the Notarial Section to answer any legal queries in a timely manner and ensures a quality of service to clients in line with the existent Quality Service Charter;
- xiii. Promotes the Notarial Archives, as delegated by the Chief Notary to Government;
- xiv. Manages court cases, as delegated by the Chief Notary to Government;
- xv. Undertakes any other tasks, which the Chief Notary to Government may delegate to him/her as may be required, including in the Office of the Notary to Government in Gozo.
- xvi. Any other duties as directed by the Principal Permanent Secretary.
