Duties and responsibilities

- i. assists in the delivery of health care in the hospitals and various health care settings of the Ministry for Health and Active Ageing;
- ii. works in the Department of Dentistry within the Ministry for Health and Active Ageing. The appointee may also provide services in various clinics, which may include dental clinics in Gozo General Hospital, and any future clinics within the Primary Health Care.
- iii. works at all times under the supervision of his/her seniors and will be directly accountable to the Consultant/Senior in Charge and finally to the Clinical Chairperson of the Department of Dentistry;
- iv. participates in academic activities organized within the Department of Dentistry;
- v. Successfully completing the requirements of the General Professional Training Programme (CCGPT) for General Professional Trainee (Dentistry);
- vi. makes use of the Information Technology systems which may be in operation within the Ministry for Health and Active Ageing.
 - i. undertakes any other tasks, which the superior may delegate to him/her, as may be required;
 - ii. any other duties as directed by the Principal Permanent Secretary.
