- iv. successfully completes the requirements of the Foundation Programme as specified in the Reference Guide together with those specified by the Malta Foundation School wherein further information is available on the website (<https://fpmalta.gov.mt/>);
- v. makes use of the Information Technology systems which may be in operation within the Ministry for Health and Active Ageing;
- vi. undertakes any other tasks, which the superior may delegate to him/her as may be required;
- vii. undertakes any other duties as directed by the Principal Permanent Secretary.
