- vii. Jaħdem b'dejta xjentifika u rapporti analitiċi, databases u GIS u jassisti fit-tnejn ta' rapporti għas-sottomissjoni lill-Kummissjoni Ewropea u lil diversi korpi internazzjonali;
- viii. Jipparteċipa u jagħmel rappreżentazzjonijiet f'firxa ta' laqgħat, seminars, kunitati u pjattaformi ta' diskussjoni nazzjonali, tal-UE u internazzjonali;

## Duties and responsibilities

- i. Keeps abreast with, and provides input to, relevant EU and international policy developments in the areas related to conservation of wild birds;
- ii. Draws up internal memoranda and draft legislative and policy proposals on matters related to sustainable hunting governance and conservation of wild birds;
- iii. Assists in the planning, procurement, and monitoring of execution of scientific studies and any other services and supplies required for the overall function of the Wild Birds Regulation Unit (WBRU);
- iv. Assists in procurement, budgeting, internal resource planning and other related functions;
- v. Plans and administers licensing and permitting procedures for various activities regulated by the WBRU;
- vi. Assists in the preparation of communication material relevant to the functioning of the WBRU, including mailing letters and materials relevant to the unit's website and social media;
- vii. Works with scientific data and analytical reports, databases and GIS and assists in the preparation of reports for submission to the EU Commission and to various international bodies;
- viii. Participates and represents in a range of national, EU and international meetings, seminars, committees and discussion platforms of relevance to the functioning of the unit;
- ix. Follows up and keeps track of internal and external deadlines related to this position's area of responsibility and liaises with the relevant entities within the appropriate Government structures in order to ensure that deadlines are met in a timely and efficient manner;
- x. Undertake any other tasks, which the superior may delegate to them, as may be required; and
- xi. Any other duties as directed by the Principal Permanent Secretary.
