## Duties and responsibilities

- I. undertaking tasks assigned and ensuring such tasks are completed;
- II. acting in compliance with established Hospital Fire Safety Strategy, including Established Hospital Fire Safety Policy and Procedures;
- III. acting as focal points for Fire Safety Issues for Hospital Staff;
- IV. in consultation, organising and assisting in the Hospital Fire Safety regime within Departments and other sectors;
- V. raising issues regarding fire safety with Line Management;
- VI. actively assisting in any fire incidents;
- VII. being trained to tackle fires with First Aid Fire Fighting Equipment;
- VIII. supporting Line Management in Fire Safety Issues;
- IX. assisting, scheduling and coordinating in Fire Drills; including respective documentation;
- X. monitoring and reporting on General Fire Safety, First Aid Fire Equipment, and Good Housekeeping throughout the Hospital;
- XI. concurrently reporting to Head of Section of the Fire and Safety Unit;
- XII. monitoring and reporting on the No Smoking Policy;
- XIII. assisting Emergency Civil Protection Department Site Operations;
- XIV. monitoring and reporting on Hot Work Permits; attending LPG & medical oxygen fill-up;
- XV. attending with third party contractors to follow up and check repairs of fire-related equipment, including fire doors, dry and wet risers, fire alarm and any other related equipment.
- XVI. Undertakes any other tasks, which the superior may delegate to him/her, as may be required;
- XVII. Any other duties as directed by the Principal Permanent Secretary.
