### Duties and responsibilities

The duties of General Practitioner Trainee include:

- i. works in the respective Department within the Ministry for Health and Active Ageing. He/she will work at all times under the supervision of his/her seniors and will be directly accountable to the Principal General Practitioner in charge and ultimately to the Clinical Chairperson;
- ii. participates in academic activities organized by the respective Department within the Ministry for Health and Active Ageing;
- iii. successfully completes the requirements specified in the respective training curriculum and exigencies of the Specialty as approved by the Specialist Accreditation Committee of Malta;
- iv. be required to undertake home visits for patients needing this service by making use of own vehicle;
- v. undertakes any other tasks, which the superior may delegate to him as may be required ;
- vi. makes use of the Information Technology systems which may be in operation within the Ministry for Health and Active Ageing ;
- vii. undertakes any other tasks, which the superior may delegate to him/her, as may be required;
- viii. carries out any other duties as directed by the Principal Permanent Secretary.
