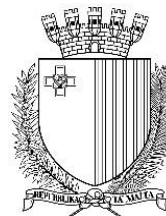

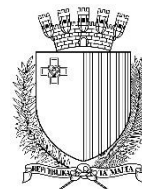

Duties and responsibilities

- i. Participates in research and development initiatives undertaken by the Ministry for Agriculture, Fisheries and Food Supply;
- ii. Participates in EU funding applications as may be needed;
- iii. Participates in the gathering of statistics and information as requested by the Ministry, particularly in relation to veterinary medicinal products containing antimicrobials and other data related to veterinary medicinal products;
- iv. Participates in all regulatory procedures relating to the authorisation, retail, distribution, manufacture, research and control of veterinary medicinal products;
- v. Participates or collaborates in relevant initiatives in the strategy and action plan for the prevention and containment of antimicrobial resistance in Malta 2020-2028;
- vi. Participates in all procedures pertaining to licensing or authorisation of manufacturers, wholesalers and retailers of veterinary medicinal products;
- vii. Conducts inspections, audits and collection of samples as may be needed;
- viii. Participates in drafting law and legal notices relating to all the above-mentioned areas;
- ix. Is involved in disciplinary/legal action with regards to all above-mentioned areas;
- x. Draws up scientific and technical reports in competent areas;
- xi. Helps to draw up and implement budgets, in particular for EU related programmes, surveys and projects;
- xii. Represents the Department at local, European Union and international conferences, meetings and workshops as required;
- xiii. Undertakes any other tasks, which the superior may delegate to him/her, as may be required;
- xiv. Undertakes any other duties which may be updated to meet the requirements of any other area as confirmed by the Permanent Secretary;
- xv. Any other duties as directed by the Principal Permanent Secretary.
