- iii. Jirrispondi għal emergenzi veterinarji u jwettaq dmirijiet relatati mat-tmexxija u l-operat ta' stabbilimenti veterinarji.
- iv. Jinforza l-leġiżlazzjoni u r-regolamenti kollha Maltin u Ewropej, kif ukoll l-istandards internazzjonali applikabbli fil-qasam tas-saħħa u l-ħarsien tal-annimali.
- v. Jagħmel spezzjonijiet u investigazzjonijiet uffiċjali, jiġbor evidenza u fejn meħtieġ, jipprezentaha quddiem il-Qorti.
- vi. Jiżgura l-osservanza shiħa tar-regolamenti dwar is-saħħa u s-sigurtà fuq il-post tax-xogħol u jippromwovi ambjent tax-xogħol sigur għall-persunal ta' appoġġ.
- vii. Iwettaq dmirijiet addizzjonali barra mill-funzjonijiet normali tal-kariga meta jkun meħtieġ biex jiġu indirizzati htigijiet operazzjonali, nuqqas ta' persunal jew sitwazzjonijiet ta' emergenza, skont il-proċeduri stabbiliti.
- viii. Jieħu r-responsabbiltajiet delegati lilu fi hdan il-funzjonijiet tad-Direttorat u jikkontribwixxi għat-twassil effettiv tas-servizzi veterinarji.
- ix. Jattendi u jipparteċipa f'taħriġ u f'attivitajiet ta' żvilupp professjonali kontinwu kif mitlub mid-Direttorat.
- x. Jikkollabora ma' kollegi u ma' awtoritajiet oħra biex jiżgura l-implimentazzjoni effettiva tal-politiki dwar il-ħarsien tal-annimali u s-servizzi veterinarji.
- xi. Iżomm l-oġhla standards ta' professjonalità, integrità u responsabbiltà fl-aspetti kollha tal-prattika veterinarja.

Duties and Responsibilities		

- i. Carry out all duties assigned by senior management with professionalism, competence, and in accordance with the ethical standards of the veterinary profession.
- ii. Provide veterinary care, including clinical consultations, diagnosis, medical treatment, neutering, and general surgical procedures for animals.
- iii. Respond to veterinary emergencies and perform duties related to the operation and management of veterinary establishments.
- iv. Enforce all applicable Maltese and European legislation, regulations, and international standards relating to animal health and welfare.
- v. Undertake inspections, investigations, and other official duties, including collecting evidence and presenting it in court when required.
- vi. Ensure full compliance with occupational health and safety requirements and promote a safe working environment for support staff.
- vii. Perform additional duties outside the normal remit of the post when required to address operational needs, staff shortages, or emergency situations, in accordance with established procedures.
- viii. Accept delegated responsibilities within the functions of the Directorate and contribute to the effective delivery of veterinary services.
- ix. Attend and participate in training and continuous professional development activities as directed by the Directorate.
- x. Collaborate with colleagues and other authorities to ensure the effective implementation of animal welfare policies and veterinary services.
- xi. Maintain high standards of professionalism, integrity, and accountability in all aspects of veterinary practice.
- xii. Undertakes any other duties which may be updated to meet the requirements of any other area as confirmed by the Permanent Secretary;
- xiii. Undertake any other tasks, which the superior may delegate to him/her, as may be required;
- xiv. Any other duties as directed by the Principal Permanent Secretary
