Duties and responsibilities

- i. Promotes and safeguards the rights and interests of persons with mental disorders and their carers to continually keep issues concerning this vulnerable cohort at the top of the national agenda
- ii. Assists the Commissioner for the Promotion of Rights of Persons with Mental Disorders in carrying out their functions as established under the Mental Health Act
- iii. Works in liaison with all relevant stakeholders including policy makers, public, private and church entities, patient representative groups and related non-governmental organizations within the mental health field and beyond
- iv. Reviews and influences legislation and policies for the safeguarding of the rights and interests of persons with mental disorders and their carers
- v. Increases the awareness and knowledge of the general public about mental health and persons with mental health disorders
- vi. Facilitates synergistic action and innovation in relation to issues related to Mental Health and Mental Wellbeing
- vii. Ensures a mental-health-in-all-policies approach
- viii. Carries out and contributes to research as required by the Office of the Commissioner for Mental Health. Remains up to date on national and international developments and legislation in the field of Mental Health
- ix. Participates when asked in various boards as required
- x. Be responsible for the supervision of staff under his/her charge
- xi. Makes use of the Information Technology systems which may be in operation within the Office of the Deputy Prime Minister and Ministry for Health
- xii. Undertakes any other tasks, which the superior may delegate to him/her, as may be required
- xiii. Carries out any other duties as directed by the Principal Permanent Secretary
