- iv. Jikkontribwixxi għall-formulazzjoni tal-politika u jwieġeb għat-talbiet għal deċiżjonijiet ta' politika jew informazzjoni meħtieġa mill-istituzzjonijiet tal-UE b'mod li jiżgura azzjoni f'waqtha u kkoordinata;
- v. Jmexxi l-koordinazzjoni u l-iżvilupp ta' għażliet ta' politika domestika allinjati mar-rekwiżiti tal-UE u jissorvelja l-proċessi ta' traspożizzjoni biex jiżgura preċiżjoni u konformità legali;
- vi. Jistabbilixxi sistemi ta' monitoraġġ biex jimmonitorja l-progress tal-attivitajiet relatati mal-UE u jindirizza b'mod proattiv kwalunkwe ostaklu fl-implimentazzjoni;
- vii. Jmexxi l-koordinazzjoni inter-Ministerjali u mal-partijiet interessati biex jipproduċi dokumenti ta' pożizzjoni tal-Ministeru komprensivi u bbażati fuq analiżi tal-impatt li jirriflettu l-perspettiva tal-Gvern kollu;
- viii. Jiżgura konformità sħiħa mal-obbligi u l-impenji tal-UE, u jimplimenta mekkaniżmi ta' monitoraġġ biex jiggarrantixxi l-osservanza tal-iskadenzi;

- x. Jikkoordina u jissorvelja l-attivitajiet tal-proġetti kollha ffinanzjati mill-UE li jaqgħu taht ir-responsabbiltà tal-Ministeru, u jikkoordina mal-Awtorità tat-tmexxija biex jiżgura li l-progress meħtieġ u r-rapporti finanzjarji jithejjew fil-ħin mill-mexxejja tal-proġett;
- xi. Jissorvelja l-organizzazzjoni tal-laqqgħat mal-mexxejja tal-proġetti u t-thejjija tal-minuti u jimmonitorja l-azzjoni ta' segwitu filwaqt li jiżgura li r-riżultati tal-proġett jitlestew fil-ħin;
- xii. Jivverifika l-eligibbiltà tat-talbiet kollha għall-ħlas u jissorvelja l-ħruġ ta' fondi fir-rigward ta' proġetti kofinanzjati mill-UE li jaqgħu taht il-kompetenza tal-Ministeru;

Duties and Responsibilities		

- i. Ensures the effective and timely coordination of all EU-related processes and procedures for dossiers under the Office of the Prime Minister;
- ii. Leads the identification of key EU policy areas of strategic importance where Malta may wish to take a proactive role in piloting such policies through the EU institutions;
- iii. Oversees and validates policy documentation including instruction notes, briefing papers, and speaking points for Council, COREPER and committee meetings while ensuring cross-alignment between Ministries, PRM and EU Coordination Department;
- iv. Contributes to policy formulation and responds to requests for policy decisions or information required by the EU institutions in a timely and co-ordinated action;
- v. Leads the coordination and development of domestic policy options aligned with EU obligations and oversees transposition processes to ensure accuracy and legal conformity;
- vi. Establishes monitoring systems to track progress on EU-related activities and proactively resolves barriers to implementation;
- vii. Leads inter-Ministerial and stakeholder coordination to produce comprehensive, impact-assessed Ministry position papers reflecting whole-of-government perspectives;
- viii. Ensures full compliance with EU obligations and commitments, implementing monitoring mechanisms to guarantee adherence to deadlines;
- ix. Directs the management, classification and secure dissemination of EU-related information in line with established security protocols and Ministry standards;
- x. Co-ordinates and oversees activities of all EU funded projects falling within the responsibility of the Ministry, and co-ordinates with the Managing Authority to ensure that the necessary progress and financial reports are prepared on time by the project leaders;
- xi. Oversees organisation of meetings with the project leaders and preparation of minutes and monitor the follow up action while ensuring that project deliverables are completed on time;
- xii. Verifies the eligibility of all payment claims and monitors the disbursement of funds with regard to EU co-financed projects falling within the remit of the Ministry;
- xiii. Participates in training and represents the Ministry and the Directorate in meetings locally and abroad as required and undertakes any other tasks, which the superior may delegate to him/her as may be required;
- xiv. Keeps up to date with public service procedures and regulations and provide guidance to departments and entities accordingly;
- xv. Any other duties as directed by the Permanent Secretary and the Principal Permanent Secretary.
