Duties and responsibilities

The duties of Higher Allied Health Practitioner include:

- i. manages the provision of a professional service in a specific clinical area / unit in an efficient and timely manner;
- ii. takes on responsibility for all staff, students and support staff working in that area;
- iii. encourages an environment that is conducive to a multi-disciplinary health team to provide the best patient outcomes;
- iv. fosters a sense of patient care accountability and responsibility across the health care team;
- v. develops these clinical units and areas in accordance with established policy;
- vi. liaises with other Practitioners within the service to promote and develop co-ordinated services of high standard, whilst ensuring compliance with all related legislation, regulations and standards;
- vii. is responsible for the effective and efficient deployment of staff on the specific units;
- viii. deputises and carries out any other duties as requested in response to the exigencies of the service
- ix. undertakes any other tasks, which the superior may delegate to him/her, as may be required;
- x. any other duties as directed by the Principal Permanent Secretary.
