- x. jipparteċipa fil-verifiki u jkun sugġett għall-prestazzjoni annwali u jipparteċipa f'bordijiet tal-għazla, ta' dixxiplina u ta' akkwist;
- xi. jipparteċipa f'laqgħat multidixxiplinarji u f'laqgħat tal-morbidita' u ta' mortalita';
- xii. jipprovdi servizz ta' għassa wara l-hin normali tax-xogħol kif dettat mill-Chairperson Kliniku;
- xiii. jieħu kwalunkwe kompitu ieħor li s-superjur jista' jiddelega lilu, kif jista' ikun meħtieġ;
- xiv. jagħmel użu mis-sistemi tat-Teknologija tal-Informatika li jkunu qed jintużaw fil-Ministeru għas-Saħħa.

## Duties and responsibilities

The duties of Resident Specialist (Anaesthesia) on Locum Basis include:

- i. form part of the Department of Anaesthesia, Intensive Care and Pain Management and will be accountable to the respective Consultant and ultimately to the Clinical Chairperson;
- ii. perform duties in the Department of Anaesthesia, Intensive Care and Pain Management and will be expected also to provide patient care in the Intensive Care Unit , Obstetric Unit and Pain Clinics;
- iii. supervise the work of medical staff below the level of Resident Specialist which also includes careful review of patient records to make sure that they are accurate, up to date and legible;
- iv. perform any theatre list and to show special interest in an anaesthetic subspecialty;
- v. show initiative and innovation and to provide methods of epidural analgesia and post-operative pain relief;
- vi. work and take decisions in the clinical field;
- vii. participate in any teaching or training programme for undergraduates or postgraduates as required and to involve himself in on-going research programmes;
- viii. require to establish appropriate mechanisms to ensure quality of service and medical audit;
- ix. deputising for Consultants as necessary and provide cover for other colleagues in an emergency or when on vacation leave or other leave.
- x. participate in audits and be subject to annual performance appraisals and participates when asked in selection boards, disciplinary boards and procurement boards;
- xi. participate in audits, multidisciplinary meeting, mortality and morbidity meetings
- xii. provide residents on call service after normal working hours as direct by the Clinical Chairperson.
- xiii. undertakes any other tasks, which the superior may delegate to him as may be required;
- xiv. make use of the Information Technology systems which may be in operation within the Ministry for Health;
- xv. perform any other duties according to the exigencies of the Public Service as directed by the Principal Permanent Secretary.
