Il-persuna maħtura bħala għalliem hija mistennija li tikkollabora ma' edukaturi li jkun qed jappoġġaw dan l-isforz fil-klassi jew barra mill-klassi, taħt it-tmexxija tas-*Senior Management* Tim tal-iskola, anke billi jinvolvu ruħhom fl-iżvilupp tal-Komunità ta' Edukaturi Professjonali, inkluż fi ħdan l-*iSchool Development Plan*. Biex dan isehh, il-persuna magħżula bħala għalliem għandha:

- i. żżomm ruħha aġġornata mal-iżviluppi fl-edukazzjoni, b'mod partikulari fir-rigward taċ-ċiklu u/jew qasam rispettiv, inkluż iżda mhux limitat għall-kurrikulum, il-pedagoġija, l-assessjar, ir-*recording*, u r-rappurtar ta' taġħlim, il-kontenut u l-iżvilupp differenti ta' min jitgħallem;
- ii. toħloq kundizzjonijiet tajbin biex tiffacilita l-iżvilupp holistiku ta' min qed jitgħallem skont il-linji gwida pprovduti mill-awtoritajiet nazzjonali u lokali nominati;
- iii. tippjana, toħloq u tevalwa esperjenzi ta' taġħlim stimulant, pjaċevoli u pożittivi, inkluż fil-preparazzjoni ta' lezzjonijiet u kif tagħti l-lezzjonijiet, fl-iżvilupp u amministrazzjoni ta' modalitajiet varji ta' assessjar għal u ta' taġħlim, kif ukoll tagħti *feedback* ukoll permezz ta' *registrazzjoni* u rappurtar tat-tagħlim;
- iv. tindirizza d-diversità billi toħloq opportunitajiet għall-istudenti kollha biex jilħqu l-potenzjal tagħhom mingħajr ma formalment jew informalment joħolqu ostakli jew inaqqsu l-aspettattivi;
- v. tikkontribwixxi għall-kisba inkrementali tar-riżultati mistennija fis-suġġett, qasam ta' taġħlim u l-livell ta' temi trans-kurrikulari tal-istudenti kollha fdati taħt il-kura tiegħu/tagħha, billi tgholli l-limitu tal-kisba għal kull individwu u jitnaqqas l-lakuni fil-kisba li jistgħu jeżistu fil-proċess billi tiffacilita t-twertiq tal-potenzjal ta' kull student;
- vi. it-tagħlim u l-edukazzjoni tal-istudenti skont il-linji gwida pprovduti mill-Qafas tal-Kurrikulu Nazzjonali taħt il-gwida totali tal-awtorità kompetenti tal-edukazzjoni;

- vii. t-tagħlim u l-edukazzjoni tal-istudenti skont il-htigijiet, il-ħiliet u l-potenzjal edukattiv ta' studenti individwali fdati fil-kura tiegħu/tagħha mill-Kap tal-Iskola jew Kap tas-Sezzjoni;
- viii. kwalunkwe kompitu ieħor li s-superjur jista' jiddelega lilu/ha, kif jista' jkun meħtieġ; u
- ix. kwalunkwe dmir ieħor hekk kif ordnat mis-Segretarju Permanenti Ewlieni.

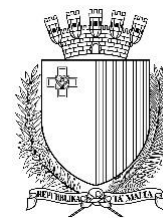

Duties and responsibilities

It is the responsibility of a teacher to take charge of providing appropriate relevant, stimulating and engaging learning experiences for all students under his/her responsibility, nurturing wellbeing through sustainable individual as well as collective spiritual, emotional, cognitive and physical growth. The teacher is expected to collaborate with other educators, who may be supporting this endeavour within or beyond the classroom, under the leadership of the school's Senior Management Team, also by engaging in the development of a Community of Professional Educators, including through School Development Planning. In pursuing this, the Teacher is to:

- i. keep abreast of developments in education, particularly in relation to the respective Cycle and/or area, including but not limited to curriculum, pedagogy, assessment, recording and reporting of learning, content and diverse learner development;
- ii. create optimal conditions which facilitate a learner's holistic development according to guidelines provided by the national and local designated authorities;
- iii. plan, create, and evaluate stimulating, enjoyable and positive learning experiences, including through lesson preparation and delivery, development and administration of varied modalities of assessment for and of learning, as well as give feedback also through recording and reporting of learning;
- iv. address diversity by creating opportunities for all learners to reach their potential without either formally or informally erecting barriers or lowering expectations;
- v. contribute towards the incremental attainment of the expected outcomes at subject, learning area, and cross-curricular theme level by all students entrusted under his/her care raising the bar of achievement for every individual and narrowing the attainment gaps that may exist in the process facilitating the fulfilment of each learner's potential;
- vi. teach and educate students according to guidelines provided by the National Curriculum Framework under the overall guidance of the competent education authority;
- vii. teach and educate students according to the educational needs, abilities and attainment potential of individual students entrusted to his/her care by the Head of School or Head of Section;

- viii. undertake any other tasks, which the superior may delegate to him/her, as may be required; and
- ix. any other duties as directed by the Principal Permanent Secretary.

The selected candidate is expected to carry out his/her duties in utmost good faith, with due diligence and to the best of his/her abilities and s/he shall act in all respects according to the instructions and/or directives given to him/her by the Education Directorates, Head of College Network and/or Head of School.

The selected candidate is required to follow professional development courses including an induction course as appropriate to his/her role and functions, and Management driven training programmes, as directed by the Education Directorates, Head of College Network and/or Head of School.

The selected candidate shall adopt and work towards the implementation of the school development plan of the particular school or schools s/he is giving service in.

The selected candidate may be assigned to serve in any College, School, Resource Centre, Learning Support Centre or educational institution including serving in more than one school/centre/institution, in Malta and/or Gozo. MEYR reserves the right to deploy selected candidates from one College/school/centre/institution to another according to the exigencies of the MEYR, including on a shared basis.
