Ir-Research Analyst huwa responsabbli li jagħti pariri lir-Rappreżentant Permanenti kif ukoll lill-entitajiet rilevanti fi ħdan il-Gvern, kif ukoll jikkoordina kull ħidma u jsegwi kwalunkwe kwistjoni teknika fuq is-suġġetti fil-qasam li tiegħu ikun responsabbli fi ħdan ir-Rappreżentanza. 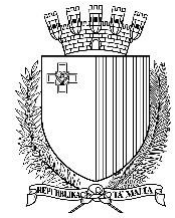

Duties and responsibilities

The Research Analyst supports the work of the Economic and Financial Affairs and Trade Unit within the Permanent Representation of Malta to the European Union (PREU) and the wider PREU team. The Research Analyst reports directly to the Permanent Representative of Malta to the European Union and must be able to work independently (in line with the relevant Government and PREU internal procedures). The Research Analyst is responsible for providing advice to the Permanent Representative and to other relevant entities within the Government, as well as coordinating any tasks and following up on any issues on the topics of falling in their remit within the Permanent Representation. A background that enables the Research Analyst to understand the complexities and give feedback on the different issues arising from the EU acquis related to economics, accounting, financial services, fiscal matters, banking, law or trade may be an asset.

This Position Description is indicative of the tasks and responsibilities.

External

- i. Keeping track of developments in all EU institutions, bodies and agencies relevant to this position's area of responsibility, collecting, scrutinising and disseminating relevant documentation issued by EU Institutions, and preparing analyses and recommendations (primarily on impact on Malta's socio-economic situation and legal framework) to the Permanent Representative and other officials as necessary;
- ii. Alerting the Permanent Representative (in a timely manner) to issues requiring a response from the Ministry or other line Ministries, and providing advice and input in the development of Malta's position on such issues;
- iii. Representing Malta in Council preparatory bodies and other EU fora dealing with this position's area of responsibility, putting forward Malta's position and participating in discussions in accordance with the Instruction Note to which the Research Analyst must also be able to contribute;
- iv. Establishing networks with other Member States as well as within the EU institutions, bodies and agencies, particularly (but not limited to) within the Commission and the European Parliament, in order to actively advocate for Malta's position;
- v. Communicating developments to the Permanent Representative and advising on follow-up action to be taken, duly informing other officials in the Permanent Representation in Brussels, the EU Coordination Department and other Government structures as appropriate;
- vi. Working with the units at the Permanent Representation, Ministries and EU Coordination Department and providing expert input with regard to the Malta's position;
- vii. Compiling and sending reports immediately after the completion of meetings in line with the approved Distribution List and reporting procedures, as well as alerting, by telephone/message, the Ministry concerned, the EU Coordination Department and the Cabinet of the Permanent Representative in the event of issues needing immediate attention;

- viii. Drawing up of Briefing Notes and Background Notes as well as Speaking Notes and communications to the Institutions related to this position's area of responsibility as and when required;
- ix. Providing input to Chef de Cabinet/Antici/Mertens/Nicolaidis for the compilation of the necessary dossiers and briefs, COREPER II, COREPER I and PSC meetings, as well as any other meetings of the Permanent Representative;
- x. Undertaking research in the relevant area of responsibility and providing advice and input based on the research undertaken;
- xi. Supporting the team and other units, as necessary, including (but not limited to) covering meetings for other PREU officers as and when necessary;
- xii. Any other task assigned by the Permanent Representative.
